Policy Memorandum 21-001: COVID-19 Procedures for MMYBL Teams for 2021-2022

1. MMYBL will adopt the following policies and procedures for league operations to comply with the Agency of Education (AOE) and Vermont Department of Health (VDH), Vermont Principals Association (VPA), and Mount Mansfield Union Unified School District (MMUUSD) policies and guidelines for COVID-19 effective this date.
2. **Governing Policies: When MMYBL policies conflict with AOE, VPA, or VDH policies, the league will follow the State of Vermont or MMUUSD Policies.**
3. **Applicability:** The policies and procedures outlined in this Policy Memorandum apply to all Mini-Metro, AAU, and Recreational League teams, MMYBL Board Members, Volunteer Staff and Parents, and Spectators unless otherwise specified.
4. **Possible Exposure due to Contract Tracing:** When a member of the MMYBL Community receives the notification of possible exposure to COVID-19 due to contact tracing, they will immediately report this notification to their team coach and MMYBL President. MMYBL community members will follow testing and quarantine procedures given to them by VDH until they are considered clear of any exposure risk through required testing and evaluation protocols. Until VDH and qualified health professionals medically clear them, they will not participate in any MMYBL events.

5. **Symptoms related to COVID-19:** When any member of the MMYBL Community exhibits symptoms related to COVID-19 onset, they will immediately remove themselves from all MMYBL activity. MMYBL members will return once cleared for return through VDH policies and procedures administered through qualified health professionals. Any MMYBL community member that has the onset of symptoms after attending any MMYBL practice, scrimmage, or game will immediately notify the team coach and MMYBL President.

6. **Positive Test for COVID-19:** Any MMYBL Community Member that has a positive test for COVID-19 antigens or is diagnosed with COVID-19 will immediately cease all activity with MMYBL until cleared for return under policies established VDH, VDE, and MMUUSD. MMYBL Community members are expected to report this information directly to their team coach and MMYBL President within the confines of the Health Information Privacy Protection Act (HIPPA) to protect health information so that MMYBL can determine any requirements for contact tracing and reporting. **MMYBL will provide the MMUUSD COVID Coordinator with a roster of all players present at any practices/games prior to or after the confirmed test result, with the date and location of the practice/game event. Team Coaches will immediately notify their teams of any positive test from any player on their team.**

7. **Practice and Play guidelines:** MMYBL players will follow practice and gameplay policies outlined by VDH and VPA for Middle School sports. These guidelines will include all policies outlined for wearing masks by coaches, players, spectators, and staff related to mask wear and restricted access and social distancing.
